 - ii. Machinery purchased on 15-01-2020 for Rs 2,00,000 (excluding 12% GST) from a local dealer in Kerala eligible for input tax credit. Depreciation @ 15% pa.
 - iii. Manufacturing expenses and profits Rs 1,50,000.
 - iv. Goods produced were sold outside Kerala with IGST @ 18% on sales.

Calculate the amount of CGST and SGST payable after utilizing input tax credit for the month of January 2020 assuming there is no opening balance of input tax credit available.
